Neither Central Bank of Boone County nor the Columbia Art League will be responsible for works that have not been picked up during this period of time. Any art not picked up at the Columbia Art League after 30 days from the end of the show will become property of CAL.

I understand a commission of 35 percent will be charged for all art work sold while on exhibit at the bank. Revenue is used to support the Columbia Art League's community activities. A red dot designates pieces that have been sold. Central Bank of Boone County requests permission to exhibit selected entries until November 15, 2024. A green dot will designate these works.

Art work by me in this exhibit has been completed within the last 12 months and I am a resident of Boone County, a Columbia Art League Member or a full-time student in Columbia.

My submitted artwork is my own original work, and not under contract with any other establishment. I confirm that it is not a copy or likeness of another artist's work including published photographs or reference material not attributable to me.

### Important Dates:

Last day to enter: Sept. 28 at 5 p.m.

Drop off Day: Oct. 11 between 6 p.m. and 7 p.m.

Pick Up Day: Oct. 13 between 5 p.m. and 6 p.m.

All work must be ready for display, including heavy wire across the back of frames (no clip frames) and felt on the bottom of sculptures. Sculptors are encouraged to bring pedestals. **Works not properly prepared for display and painted works that are still wet will not be accepted.** Please note that works cannot be pinned, nailed, glued or otherwise attached to the walls of the bank. If you have any concerns about the display of your work, because of size, weight over 30 lbs, or other unique aspects, please contact Central Bank of Boone County at 573-874-8483 or the Columbia Art League at 573-443-8838.

### Who can enter?

Any Boone County resident, Columbia Art League member or full-time Columbia student, **18 years of age** or older, may enter one work of art that has been completed within the past 12 months.

**A professional artist** must have an art degree in any area from a college, university, or accredited art school OR they must meet at least ONE of the following criteria:

- Earns 50% of his/her yearly income from selling their artwork
- Earns over 50% of his/her yearly income from teaching art classes for reimbursement
- Attends graduate school in art
- Has an MFA.

**A non-professional artist** is considered someone who meets at least ONE of the following criteria:

- Earns less than 50% of his/her yearly income from selling their artwork
- Has limited training only through workshops or community art classes
- Has a purely vocational interest in art
- Is an undergraduate student.

### What can be entered?

Artists may only enter one work of art. Substitutions of work may not be made. **Work designated on the entry form must be the work entered in the show.** No Photography or AI art will be accepted.

### What is the deadline to enter?

Your entry form must be completed and returned to the Columbia Art League by 5 p.m. on Saturday, September 28. Entries will not be accepted after this date. **NO EXCEPTIONS.**

## What can I win?

Central Bank of Boone County provides cash prizes and ribbons in all nine of the designated categories. In addition, the bank selects a Purchase Award to be added to the bank's permanent art collection. Honorable Mention ribbons are also awarded and a Popular Choice Award is voted on by visitors.

## Medium Category

Use the listing below to identify the medium of your entry.

**Painting:** watercolor, tempera, oil, acrylic, gouache, oil pastel.

**Drawing:** pencil, charcoal, graphite, conte, ink, chalk pastel.

**Other:** mixed media, collage, jewelry, printmaking, digital painting, etc. **No Photographs or AI.**

**Sculpture:** clay, wood, metal, stone, etc.

**Ceramics:** original fired, utilitarian cast or clay. No molds.

**Fiber:** batik, woven pieces, paper, wearables.

## When do I deliver my work?

On Friday, October 13, to the Downtown Lobby of Central Bank of Boone County at 720 E. Broadway between 6 p.m. and 7 p.m. Your work will not be accepted before 6 p.m. or after 7 p.m. You will receive a receipt.

## When do I pick up my work?

The awards ceremony is Sunday, October 13 at 4:30 p.m. in the Downtown Lobby of Central Bank of Boone County at 720 E. Broadway. Plan to attend and pick up your art following the awards. To claim your work, you must present the receipt you received. You may not pick up your work before the awards ceremony.

The bank selects some of the work for an extended exhibition through November 15, 2024. Any works not selected for extended exhibition must be picked up by 6 p.m. on Sunday, October 13. If you do not pick up your work before 6 p.m., you will be charged a \$75 storage and handling fee. Any artwork not picked up from the Columbia Art League within 30 days will become the property of CAL.

## What if I just want to volunteer?

Use the same Call to Entry form. Simply complete the contact information and check off the shift you'd like to work. The Columbia Art League will contact you with specific information on volunteering for the show. You will be expected to work the shifts you have chosen to work.
